TRADEMARK ASSIGNMENT

This Trademark Assignment is made as of the 30th day of September 1998, by Macmillan, Inc., a Delaware corporation, having a principal business address at 1633 Broadway, New York, New York 10019 ("Assignor"), in favor of Robert J. Brady, Co., a Maryland corporation, having a principal business address at 201 West 103rd Street, Indianapolis, Indiana 46290 ("Assignee").

WHEREAS, Assignor owned all right, title and interest in and to the CITY-TO-GO trademark (hereinafter, the "Mark"), the application for federal registration of the Mark, Serial No. 75/558,843, and the goodwill of the business developed through the use of the Mark;

WHEREAS, Assignee was the successor to the portion of the business of Assignor to which the Mark pertained and such business was at the time of the assignment, and still is, ongoing and existing; and

WHEREAS, the parties now wish to ratify and confirm this sale, assignment and transfer of all right, title and interest in and to the Mark, the application for federal registration of the Mark, and the goodwill of the business symbolized thereby.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are acknowledged, Assignor hereby sells, assigns, transfers and sets over to Assignee, *nunc pro tunc* as of September 30, 1998, the entire right, title, and interest in and to the Mark and the pending application for federal registration of the mark, including the right to sue for past and future infringement, together with the goodwill of the business symbolized by the Mark, the same to be held and enjoyed by Assignee, its successors, assigns and other legal representatives.
