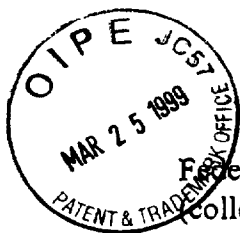

**DISCHARGE AND RELEASE OF SECURITY INTEREST; ASSIGNMENT**



FOR VALUE RECEIVED, BankBoston N.A., as agent (the "Agent"), located at 100 Federal Street, Boston, Massachusetts 02110, acting for itself and certain other lenders (collectively the "Releasors") under the Credit Agreement dated as of August 8, 1997, and any additional credit agreements, as from time to time in effect (collectively the "Credit Agreement"); do hereby release and discharge a certain security interest issued by SBA Communications Corporation ("Debtor"), to Agent and Releasors dated August 8, 1997, and recorded in the records of the U.S. Patent and Trademark Office at Reel Number 1633, Frame Numbers 0303 - 0316 (the "Security Agreement"). The Releasors hereby agree to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of said security interest contemplated hereby. This document shall constitute a discharge of the obligation for which said security interest was granted, and all assignments thereunder, and all financing statements evidencing the obligation, are hereby terminated.

If and to the extent that the Assignment of Trademarks and Service Marks of August 8, 1997 signed by Debtor and Agent, and recorded in the records of the U.S. Patent and Trademark Office at Reel Number 1633, Frame Numbers 0309 - 0316 (the "Assignment"), is deemed to have transferred to Agent and/or Releasors (collectively, "Assignors"), any rights in and to the Trademarks, Applications and Registrations listed in Exhibit A annexed hereto; or if Paragraph 6.4 of the Security Agreement is deemed to have assigned to Assignors, rights in any other trademark, application or registration owned by Debtor; then for value received, Assignors hereby assign to Debtor all right, title and interest they may have in any trademarks assigned to them by virtue of either the Assignment or the Security Agreement, together with the goodwill of the business symbolized by the marks, and any applications or registrations therefor.
