BILL OF SALE

Reference is made to that certain Consent of the Sole Director in Lieu of the Organizational Meeting of STGC Holding Corporation dated as of the 15th day of May, 1998 (the "Consent"). Subsequent to the date of the Consent, STGC Holding Corporation, a Delaware corporation, changed its name to Startec Global Holding Corporation (and it is referred to herein as "Startec Delaware"). The Consent provides, among other things, for the issuance of one (1) share of Startec Delaware common stock, par value \$.01 per share, to Startec Global Communications Corporation, a Maryland corporation ("Startec Maryland") in exchange for \$1,000 and the transfer from Startec Maryland to Startec Delaware of substantially all of Startec Maryland's assets. Startec Maryland has now received the required regulatory consents to effect such asset transfer and desires to do so through this Bill of Sale.


For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Startec Maryland hereby conveys, grants, bargains, sells, transfers, and delivers to Startec Delaware, its successors and assigns, all of Startec Maryland's right, title, and interest, legal or equitable, in all of Startec Maryland's assets, properties and contractual rights (whether tangible, intangible or otherwise) (the "Property") including, but not limited to, the Property described on Exhibit A attached hereto and made a part hereof which Startec Maryland owns, wherever such Property may be located or situated.

Startec Maryland agrees that, at any time and from time to time after the date hereof but without incurring additional expense, upon request of Startec Delaware, it will do, execute, acknowledge, and deliver or will cause to be done, executed, acknowledged, and delivered, all such further acts, deeds, assignments, transfers, conveyances, and assurances as may be reasonably required for the better assigning, transferring, granting, conveying, assuring, and confirming to Startec Delaware title to any and all of the Property which is the subject of this Bill of Sale.

Startec Maryland does hereby bind Startec Maryland's heirs, legal representatives, successors, and assigns to warrant generally and forever defend title to the Property unto Startec Delaware, its successors and assigns, against the claim or claims of any and all other persons.

IN WITNESS WHEREOF, Startec Maryland has caused this Bill of Sale to be executed by it as of the 29th day of March, 1999.
