Pursuant to O.C.G.A. Section 14-2-1006 of the Georgia Business Corporation Code, WILD ADVENTURES, INC., a Georgia Corporation, hereby submits the following Articles of Amendment:

1.

The name of the Corporation is WILD ADVENTURES, INC. and the Charter Number of the Corporation is 9418520.

Article III of the Articles of Incorporation of WILD ADVENTURES, INC. (formerly LIBERTY FARMS & CONFERENCE CENTER, INC.) is hereby amended to change the number of shares of common stock the Corporation shall have authority to issue and shall read as follows:

III. The corporation shall have the authority to issue not more than 1,000,000 shares of common stock with no par value.

The Amendment was adopted on March 16, 1998.


