**RELEASE AND TERMINATION  
OF SERVICE MARK SECURITY AGREEMENT**

KNOW ALL MEN BY THESE PRESENTS, that a certain Collateral Assignment of Service Marks and Security Agreement (the "Service Mark Security Agreement") was executed by Nassau Broadcasting Partners, L.P., a Delaware limited partnership ("Debtor"), covering the Service Mark more fully described on Schedule I annexed hereto and made a part hereof in favor of FINOVA Capital Corporation, as lender (the "Secured Party"), dated as of December 21, 1995, and recorded with the United States Patent and Trademark Office on January 29, 1996 on Reel 1426 Frame 0922. Debtor has requested and the Secured Party has agreed to release the Service Mark and discharge the Service Mark Security Agreement.



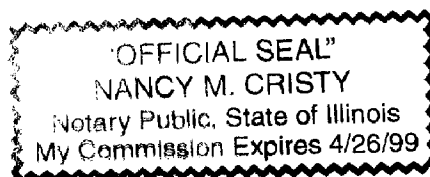
