
WHEREAS, ASSIGNEE is desirous of acquiring all rights, title, and interest in and to the Application owned by ASSIGNOR; and

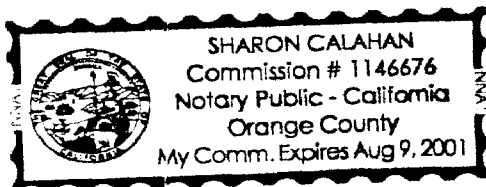
