

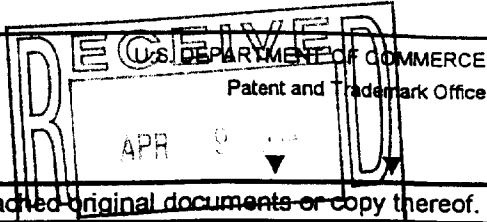

Such vote being sufficient for approval of the amendment.


