RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST dated March 29, 1999 (this "Release") is made by The Chase Manhattan Bank, a New York banking corporation ("Chase"), as Collateral Agent under the Security Agreement, dated as of May 27, 1998, among HSC Holdings, Inc., a Delaware corporation (the "Borrower"), Harris Specialty Chemicals, Inc. a Delaware corporation (the "Parent"), each subsidiary of the Borrower listed on Schedule I hereto (together with the Borrower and the Parent, collectively, the "Grantors"), and Chase. Capitalized terms used herein without definition are used as defined in the Security Agreement.

W I T N E S S E T H

WHEREAS, each of the Grantors entered into the Security Agreement in order to induce each of the Lenders to extend credit to the Borrower and the Issuing Bank to issue Letters of Credit for the account of the Borrower pursuant to the Credit Agreement dated as of May 27, 1998 (the "Credit Agreement") among the Borrower, the Parent, the Lenders, the Administrative Agent, and Chase Manhattan Bank Delaware, as Issuing Bank;

WHEREAS, pursuant to the Security Agreement, each Grantor granted to the Collateral Agent for the ratable benefit of the Secured Parties a security interest in all of its right, title and interest in, to and under its Intellectual Property, among other things;

WHEREAS, Chase has executed a letter agreement of even date herewith in which it acknowledges that all of the obligations of the Borrower and the Guarantors under the Loan documents have been paid, satisfied and discharged in full as of March 29, 1999, and in which it fully and unconditionally releases, among other things, all security interests that had been granted to the Collateral Agent pursuant to the Security Agreement;

WHEREAS, the Grantors, and the Collateral Agent for itself and the Secured Parties, desire to set forth in writing confirmation of the Collateral Agent's release of its security interest in the Grantors' Intellectual Property;


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Chase as Collateral Agent for itself and on behalf of the Secured Parties hereby fully and unconditionally terminates and releases its and their security interest in all of each Grantor's right, title and interest in, to and under its Intellectual Property, including but not limited to the Trademarks and Patents

set forth on Schedule II hereto, and any and all interest of the Collateral Agent and the Secured Parties in, to and under the Intellectual Property of each Grantor shall cease and become void.

At any time and from time to time after the date hereof, the Collateral Agent shall, at Borrower's request, execute and deliver all such other documents and perform all such other acts necessary or desirable to effectively release any and all interest of the Collateral Agent and the Secured Parties in the Intellectual Property.

IN WITNESS WHEREOF, the Collateral Agent has caused this Release to be duly executed and delivered by its duly authorized officer as of the day and year first above written.




