RELEASE AND REASSIGNMENT

THIS RELEASE AND REASSIGNMENT is executed as of March 15, 1999 by MADELEINE L.L.C., a New York limited liability company ("Madeleine").

WITNESSETH:

WHEREAS, Madeleine L.L.C., a New York limited liability company and CPV Productions, Inc., a Delaware corporation ("Debtor"), are parties to a certain Trademark Security Agreement dated as of January 15, 1997 (the "Agreement") pursuant to which Debtor incurred certain liabilities to and granted a security interest in and collateral assignment of the "Trademark Collateral" (as defined in the Agreement"), including, without limitation, the registered trademarks, trademark applications, registered servicemarks and servicemark applications (collectively, the "Trademarks") as described in Schedule A attached hereto, as security for Debtor's obligations to Madeleine under the Agreement;

WHEREAS, Debtor has satisfied its obligations under the Agreement and has requested that Madeleine release its security interest in the Trademark Collateral and reassign the same to Debtor;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Madeleine hereby releases its security interest in and collateral assignment of the Trademark Collateral.
2. Madeleine hereby reassigns, grants and conveys to Debtor, without any representation, recourse or undertaking by Madeleine, all of Madeleine's right, title and interest, if any, in and to the Trademark Collateral including without limitation, all of the Trademarks appearing in Schedule A and all the goodwill of said Debtor's business associated with and symbolized by the Trademarks appearing in Schedule A.
