

2. Any and all rights to sue at law or in equity for any infringement, imitation, impairment, distortion, dilution or other unauthorized use or conduct in derogation of the Trademarks occurring prior to the execution of this Assignment, including the right to receive all proceeds and damages therefrom; and
3. Any and all rights to obtain renewals or other legal protections pertaining to the Trademarks.

Assignee, its successors and assigns, shall hold the rights to the foregoing for and during the existence of such Trademarks, and all renewals thereof, as fully and as entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made.




This Assignment shall be governed by and construed in accordance with the laws of the State of New York without regard to its conflict of laws principles.


