The undersigned, a duly authorized officer of Radiant Systems, Inc., a Georgia corporation, the surviving corporation of the merger of Radiant Hospitality Systems, Inc. with and into Radiant Systems, Inc. (the "Merger"), pursuant to Section 14-2-1105 of the Georgia Business Corporation Code, as amended, hereby executes this Certificate of Merger.

I.

The names of the corporations which are parties to the Merger are Radiant Systems, Inc., a corporation organized under the laws of the State of Georgia ("Radiant Systems"), and Radiant Hospitality Systems, Inc., a corporation organized under the laws of the State of Georgia ("Radiant Hospitality"). Radiant Hospitality shall be merged with and into Radiant Systems, and Radiant Systems will be the surviving corporation (hereinafter the "Surviving Corporation").

II.

Upon the effectiveness of the Merger, the Articles of Incorporation of the Surviving Corporation shall be the same as the Articles of Incorporation of Radiant Systems as they exist as of the date of filing of this Certificate of Merger.

III.

The executed Plan of Merger, dated as of October 31, 1998, adopted by Radiant Systems (the "Plan of Merger"), is on file at the principal place of business of the Surviving Corporation, the address of which is 3925 Brookside Parkway, Alpharetta, Georgia 30022.

IV.

A copy of the Plan of Merger will be furnished by the Surviving Corporation, on request and without cost, to any shareholder of either corporation that is a party to the Merger.

V.

Pursuant to Section 14-2-1104(a) of the Georgia Business Corporation Code, shareholder approval of the Merger is not required.

VI.

The request for publication of a notice of filing of this Certificate of Merger and payment therefor will be made as required by Section 14-2-1105.1(b) of the Georgia Business Corporation Code, as amended.

VII.

The Merger shall be effective as of 11:59 p.m., on October 31, 1998.
