

ASSIGNMENT OF TRADEMARK

WHEREAS, NATIONAL-STANDARD COMPANY, a Delaware corporation ("Assignor"), has adopted, used and is using in its business the trademark "BARTELL" which is registered under Reg. No. 915050 dated June 15, 1971 in the United States Patent Office; and

WHEREAS, BARTELL MACHINERY SYSTEMS CORP., a New York corporation ("Assignee"), is desirous of acquiring the entire right, title and interest in and to said trademark and the registration thereof.

Assignor further agrees it will communicate to Assignee any facts known to it respecting said trademark, and testify in any legal proceedings, sign all lawful papers, execute all divisions, continuation, substitution, renewal and reissue applications, make all rightful oaths and generally do everything necessary or desirable to aid Assignee, its successors and assigns, to obtain and/or enforce proper protection for said trademark in the United States and in any and all foreign countries.
