TRADEMARK ASSIGNMENT

AGREEMENT made effective as of the 1st day of July, 1997 by and between **Duquesne Corporation**, an Illinois corporation having its principal place of business and domicile at 726 Northwestern, Suite 329, Lake Forest, IL 60045 (hereinafter "Assignor") and **Saltor/Maxim Housewares, Inc.**, a Delaware corporation having its principal place of business and domicile at 550 Business Center Drive, Mt. Prospect, IL 60556 (hereinafter "Assignee")



1. ASSIGNOR hereby assigns to ASSIGNEE ASSIGNOR's entire right, title and interest in and to the Application and the Mark, together with the goodwill of the business appurtenant thereto and any and all rights pertaining thereto in foreign countries, including the right to sue for all past infringements thereof.

The foregoing shall be held and enjoyed by ASSIGNEE for its own use and enjoyment, and for the use and enjoyment of its successors and assigns or other legal representatives, to the end of the term or terms for which said Application may be granted, renewed or renewed as fully and entirely as the same would have been held and enjoyed by the Assignor, if this assignment had not been made.

2. ASSIGNOR agrees, upon the request of ASSIGNEE, to execute any necessary and proper oaths or affidavits relating to the Application and the Mark as required for the filing or prosecution of any issuance or renewals thereof which in the opinion of counsel for ASSIGNEE, may deem necessary or expedient.
