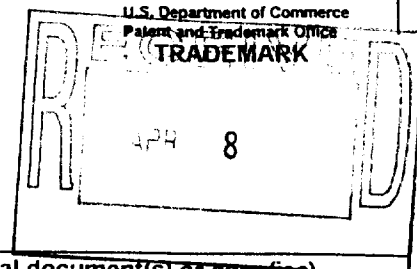



ASSIGNMENT OF SERVICE MARK


