RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (the "Release"), dated as of February 25, 1999, is made by DLJ Capital Funding, Inc. as syndication agent (the "Agent") under the Credit Agreement dated as of August 15, 1997 (amending and restating the Credit Agreement dated as of May 22, 1997) (the "Credit Agreement"), among Snapple Beverage Corp., Mystic Brands, Inc. ("Mistic"), Triarc Beverage Holdings Corp. (collectively, the "Borrowers"), the various financial institutions as are or may become parties thereto (collectively, the "Lenders"), Donaldson, Lufkin & Jenrette Securities Corporation, as the Arranger, Morgan Stanley Senior Funding, Inc., as the Co-Arranger and as Documentation Agent, and DLJ Capital Funding, Inc., as Syndication Agent and The Bank of New York as Administrative Agent.

WHEREAS, in connection with the Credit Agreement, the Borrowers have executed and delivered an Amended and Restated Borrower Security Agreement, dated as of August 15, 1997 (amending and restating the Borrower Security Agreement dated as of May 22, 1997) (the "Security Agreement");

WHEREAS, in connection with the Security Agreement, Mistic has executed and delivered an Amended and Restated Trademark Security Agreement dated as of August 15, 1997 (the "Trademark Security Agreement"), amending and restating the Trademark Security Agreement dated as of May 22, 1997 (the "May 22, 1997 Trademark Security Agreement"), pursuant to which Mistic granted a security interest in the Trademark Collateral (as defined in the Trademark Security Agreement), which includes the trademarks set forth on Schedule A attached hereto, to secure the performance of Borrowers' obligations under the Credit Agreement;

WHEREAS, the May 22, 1997 Trademark Security Agreement was recorded in the United States Patent and Trademark Office on August 8, 1997 at Reel/Frame 1619/0135; and

WHEREAS, Mistic has requested that the Agent release any and all interest it may have in the Trademark Collateral, and the Agent has agreed to do so.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, and pursuant to the Trademark Security Agreement and the May 22, 1997 Trademark Security Agreement, the Agent does hereby release, relinquish and discharge its security interest in, to and under the Trademark Collateral.

IN WITNESS WHEREOF, the Agent has caused this Release of Security Interest in Trademarks be duly executed as of the date hereinabove set forth.
