**TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS**

WHEREAS, the Assignor has satisfied all of the outstanding Obligations (as defined in the Security Agreement) and the Lender has agreed to terminate and release its security interest and its right, title and interest in the Trademark Collateral as herein provided;

NOW, THEREFORE, for valuable consideration:

The Lender hereby terminates and releases its security interest and its right, title and interest in all of Assignor's Trademark Collateral and the Lender hereby assigns and transfers to Assignor, without recourse, all of the Lender's right, title and interest in and to the Trademark Collateral effective as of the date set forth above.
