**ASSIGNMENT NUNC PRO TUNC OF UNITED STATES
TRADEMARKS AND SERVICE MARKS**

WHEREAS, CBS CORPORATION, formerly known as **WESTINGHOUSE ELECTRIC CORPORATION**, a Pennsylvania Corporation having its principal offices in New York, New York (hereinafter referred to in this Assignment as "ASSIGNOR"), and **SIEMENS WESTINGHOUSE POWER CORPORATION**, formerly known as **SIEMENS POWER GENERATION CORPORATION**, a Delaware Corporation having its principal offices in New York, New York (hereinafter referred to in this Assignment as "ASSIGNEE"), have entered into an Asset Purchase Agreement dated November 14, 1997 (as amended, the "Agreement") pertaining to sale by ASSIGNOR of certain of its assets to ASSIGNEE, (as set forth in the Agreement);

NOW, THEREFORE, pursuant to the Agreement, effective as of August 19, 1998, ASSIGNOR distributed, assigned, and transferred to ASSIGNEE, its successors and assigns, the entire right, title and interest in and to trademarks, trademark registrations and trademark applications, service marks, service mark registrations and service mark applications as identified in Schedule A attached ("marks"), together with the goodwill of the business in which the marks are used, along with any and all rights of enforcement with respect thereto, including all rights to sue or recover for the past infringement thereof, and any and all choses in action related thereto. ASSIGNOR retains no ownership rights in the properties transferred to ASSIGNEE hereunder. ASSIGNEE may apply for and receive marks in its own name wherever so permitted by law.

ASSIGNOR shall, when requested by the ASSIGNEE, execute all rightful oaths, assignments and powers of attorney, including but not limited to the right to file and prosecute in its own name, wherever so permitted by law, mark applications, including corresponding foreign applications, and to claim priority of mark applications pursuant to the international convention, to the ASSIGNEE and to agents and legal representatives of the ASSIGNEE and all other papers necessary and proper to carry out the intent and purpose of this Assignment.

IN WITNESS WHEREOF, ASSIGNOR has caused this Assignment to be executed by its duly authorized representative on this 29th day of September, 1998.


