**CERTIFICATE OF AMENDMENT OF
CERTIFICATE OF INCORPORATION
OF
SAGE NETWORKS, INC.**

Sage Networks, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of the Corporation, duly adopted, pursuant to Sections 141 and 242 of the General Corporation Law of the State of Delaware (the "GCL"), resolutions setting forth the proposed amendments to the Certificate of Incorporation of said Corporation and declaring said amendments to be advisable and directing that the amendments to the Certificate of Incorporation be presented to the stockholders of the Corporation for consideration and approval;

SECOND: That at least a majority of the stockholders of the Corporation duly approved said proposed amendments in accordance with Section 242 of the GCL by executing a Waiver of Meeting of Stockholders and Majority Written Consent to Adoption of Resolutions in accordance with Section 228 of the GCL, and written notice of such consent has been given to all stockholders who have not consented in writing to said amendments.

THIRD: The original Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on December 8, 1997. An Amended and Restated Certificate of Incorporation of the Corporation was filed with the Secretary of State of Delaware on March 2, 1998. Such certificate was amended pursuant to an Amendment to Certificate of Incorporation of the Corporation filed with the Secretary of State of the State of Delaware on July 28, 1998, an Amendment to Certificate of Incorporation of the Corporation filed with the Secretary of State of the State of Delaware on January 26, 1999 and an Amendment to Certificate of Incorporation of the Corporation filed with the Secretary of the State of Delaware on March 2, 1999.

FOURTH: That paragraph Article I of the Certificate of Incorporation, is hereby amended to read in full as follows:


"Article I
