ASSET PURCHASE AGREEMENT

This Asset Purchase Agreement (the "Agreement") is entered into as of August 31, 1998, by and among Mountainsmith, LLC, a Delaware limited liability company ("Seller"), and 105° Meridien, LLC, a Colorado limited liability company ("Buyer").

RECITALS

- A. Seller is engaged in the manufacture and sale of branded sports bags and other products.
- B. Seller desires to sell, assign and transfer, and Buyer desires to purchase and acquire, certain assets of Seller, all on the terms and conditions set forth herein.

AGREEMENT

In consideration of the foregoing and the mutual representations, warranties, promises and covenants contained herein, the parties agree as follows:

ARTICLE I PURCHASE AND SALE OF ASSETS

Section 1.1 Description of Assets to be Acquired. Upon the terms and subject to the conditions set forth in this Agreement, at the Closing (as defined in Section 5.1 below), Seller shall convey, sell, transfer, assign and deliver to Buyer, and Buyer shall purchase from Seller, all right, title and interest of Seller in and to the following assets, properties and rights of Seller:

- (a) All inventions, trade secrets, formulae, processes, technical data (including, but not limited to, documentation, testing materials and reports), art works, schematic drawings, engineering drawings, proprietary rights, proprietary knowledge, know-how, computer software, product plans, names, symbols, logos, copyrights, patents, trademarks, service marks, trade names, copyrights and all other proprietary intellectual property rights (including, but not limited to, rights in and to "Mountainsmith"), and all applications therefor, registrations thereof and licenses in respect thereof, and all goodwill associated therewith, all of the foregoing whether owned or licensed (the "Intellectual Property"), including, without limitation, those listed on Schedule 1.1(a) hereto.
- (b) Photographs, negatives, film, brochures, paste-ups and marketing materials, training materials, office and reference materials and similar items.
- (c) All purchase orders received by Seller in the ordinary course of business that have not been fulfilled as of the Closing (the "Purchase Orders").
- (d) All work in process of Seller as of the Closing.
