TRADEMARK SECURITY AGREEMENT

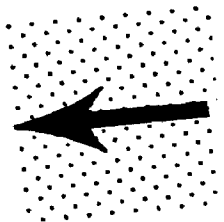

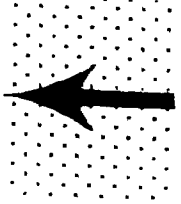
