## PARTIAL RELEASE AND REASSIGNMENT

THIS PARTIAL RELEASE AND REASSIGNMENT is made this 25<sup>th</sup> day of January, 1999 by BNY FINANCIAL CORPORATION ("BNY").

### WITNESSETH:

WHEREAS, MET-Rx USA, Inc., a Nevada Corporation and MET-RX Substrate Technology, Inc., a Nevada Corporation (collectively "Borrower") and BNY Financial Corporation, a New York Corporation, are parties to a certain Trademark Security Agreement dated as of December 29, 1997 as it may be amended from time to time (the "Loan Agreement") pursuant to which BNY made certain loans and other financial accommodations (the "Loans") to Borrower and pursuant to which Borrower granted a security interest in and to the Trademarks as each is defined below; and

WHEREAS, the Trademark mortgage was recorded in the United States Patent and Trademark Office on January 23, 1998 at Patent Reel 1679, Frames 0939; and

WHEREAS, the liabilities have been partially satisfied and, therefore, Borrower has requested that BNY release its security interest in certain of the Trademarks and reassign the same to Borrower.

**NOW, THEREFORE**, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. BNY hereby releases its security interest in Borrower's right, title and interest in and to all of its now owned or existing and filed and hereafter acquired or arising and filed:

(a) those certain trademarks, trademark registrations, tradenames and trademark applications listed on Schedule A, B. and C attached hereto and made a part hereof, and (i) renewals and extensions thereof, (ii) all income, royalties, damages and payments now and hereafter due and/or past or future infringements thereof, (iii) the right to sue for past, present and future infringements thereof, and (iv) all rights corresponding thereto throughout the world (all of the foregoing trademarks, trademark registrations, tradenames and applications, together with the items described in clauses (i)-(iv) of this subparagraph, are hereinafter referred to as the "Trademarks"); and

(b) the goodwill of Borrower's business connected with and symbolized by the Trademarks.

2. BNY hereby reassigns, grants and conveys to Borrower, without any representation, recourse or undertaking by BNY, all of BNY's rights, title and interest, in and to the above Trademarks.

**IN WITNESS WHEREOF**, BNY has caused this Partial Release and Reassignment to be duly executed by its duly authorized officer as of the day and year first above written.
