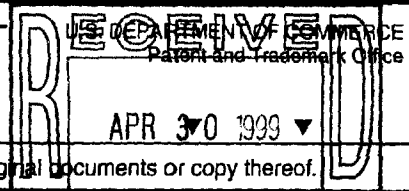

**ASSIGNMENT**


