

WHEREAS, Carina Products is the owner of U.S. trademark application serial No. 75/564,343 for SB, filed on October 5, 1998;

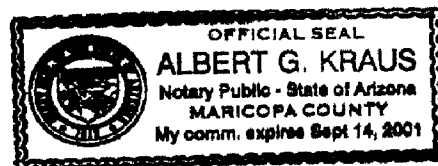
