Trade Mark Assignment Agreement

THIS ASSIGNMENT is made the 1st day of August 1995 between:

1. THE WELLCOME FOUNDATION LIMITED, a company registered in England under No. 194814 and having its registered office at Unicorn House, PO Box 129, 160 Euston Road, London, NW1 2BP ("the Assignor");

and

2. MUREX DIAGNOSTICS CORPORATION, a company registered in Barbados under No. 11016 and having its registered office at White Park House, White Park Road, Bridgetown, Barbados, W.I. ("the Assignee").

WHEREAS:

- A. The Assignor is the Registered Proprietor or applicant for registration of the Trade Marks identified in the Schedule hereto ("the Trade Marks").
