RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

WHEREAS, M&R Printing Equipment, Inc., a Delaware corporation having a place of business at 1 North 372 Main Street, Glen Ellyn, Illinois 60137 ("M&R"), and LaSalle National Bank, 135 South LaSalle Street, Chicago, Illinois 60603 ("LaSalle") entered into a certain Intellectual Property Security Agreement dated as of April 1, 1997 (the "Security Agreement");

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office, Trademark Division, on April 23, 1997 at Reel 1576, Frame 0782, and;

WHEREAS, M&R's obligations to LaSalle which were secured by the collateral subject to the Security Agreement have been paid or satisfied in full.

NOW THEREFORE, in consideration thereof and pursuant to the Security Agreement, LaSalle hereby agrees that the Security Agreement shall be and hereby is released and shall no longer have any force or effect. LaSalle cancels and terminates and does hereby cancel and terminate all rights and obligations of M&R under the Security Agreement.

LaSalle further authorizes and instructs the United States Patent and Trademark Office to discharge the Security Agreement on its records, particularly in connection with the U.S. trademarks listed in Schedule A attached hereto.

FURTHER, to the extent the Security Agreement included any trademark assignments, LaSalle re-assigns, re-conveys, re-grants, re-transfers and releases to M&R whatever rights, title and interest, if any, in and to all U.S. trademarks and U.S. trademark applications, subject to the Security Agreement, including those identified in Schedule A hereto.

IN WITNESS WHEREOF, LaSalle has caused this Release of Intellectual Property Security Agreement to be executed on this 24th day of March, 1999.
