FIRST: That at a meeting of the Board of Directors of the Company, resolutions were duly adopted setting forth a proposed amendment of the Certificate of Incorporation of said corporation, declaring said amendment to be advisable and requesting in writing the consent of the stockholders of said corporation for consideration thereof. The resolutions setting forth the proposed amendment are as follows:
