DEED OF ASSIGNMENT

WHEREAS, the United States Postal Service, of 475 L'Enfant Plaza, SW, Washington, DC 20260 ("Assignee"), has been using the term SURE MONEY for, among other things, electronic money transfer services,

WHEREAS, Harbor Federal Savings Bank of 100 S. Second Street, Ft. Pierce, FL 34950-4393, ("Assignor"), previously owned the attached federal registration, U.S. Registration No. 1,317,272 for the term SUREMONEY for banking services and the attached Florida state registration, Florida Registration No. 930000 for the term SUREMONEY for insurance and financial services,

WHEREAS, Assignor and Assignee previously entered into agreements under Contract No. 102590-98-X-2101, dated 9/8/98 and 5/7/98 respectively, whereby Assignee purchased "all rights and title to the mark" SUREMONEY, including the above-enumerated registrations for the grand total sum of \$155,000.00,

WHEREAS, Assignee has used and plans to continue using the term SURE MONEY,

NOW THEREFORE, for other good and valuable consideration, the receipt of which is hereby acknowledged:

1. Assignor confirms that it has assigned to Assignee any and all rights, title and interest in the mark, together with any goodwill of the business symbolized by the mark SUREMONEY.
2. Assignor confirms that it has assigned to Assignee any and all rights, title and interest in and to: (1) the United States registration for the mark SUREMONEY, U.S. Registration No. 1,317,272; and (2) the Florida state registration for the mark SUREMONEY, Florida Registration No. 930000.
3. Assignor agrees that it will not use the term SUREMONEY or any similar mark, for any products or services without the prior approval of Assignee or execution of a license agreement with Assignee.
4. This Agreement is binding on the parties and their officers, directors, agents, related companies, successors, and assigns.
5. Assignor warrants that it does not own any other state, federal or foreign registration for the mark SUREMONEY or any similar mark. It further warrants that no other individuals or entities have a property interest in the aforementioned federal and Florida state registrations for the mark SUREMONEY. Assignor also warrants that no other individuals or entities have been granted the right to use the mark SUREMONEY or any similar mark.

6. The parties have not relied on any representations, promises, warranties, covenants, statements, or undertakings by the other party or its counsel other than those contained in this Agreement.
