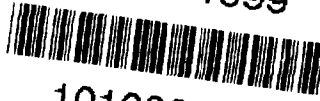

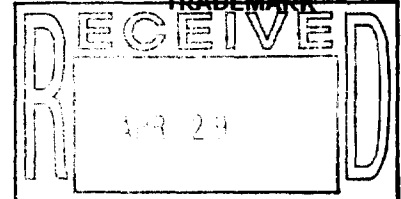

Assignor represents and warrants that it has adopted, used, is using and is the sole owner of all rights in and to the Trademarks; that it has not licensed any rights in the Trademarks to another person; and that use of the Trademarks by Assignee will not infringe upon or conflict with the rights of any person.

Assignor shall take such other actions as Assignee may reasonably request from time to time, at Assignee's expense, to assist Assignee in the recordation of transfer of ownership of the Trademarks, in infringement action against third parties, in the prosecution of applications to register the Trademarks, and in the maintenance and renewal of registrations of the Trademarks.
