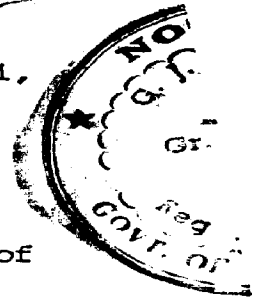
1. DEFINITION :

In this Scheme, unless repugnant to the meaning or context thereof, the following expressions shall have the following meanings :

- (i) "Act" means the Companies Act, 1956.
- (ii) "Appointed Day" means the 1st day of July, 1996.
- (iii) "CD" means the Condom Division of J. K. Chemicals Limited which is engaged in the business of manufacturing and marketing of condoms, more particularly described in Annexure A hereto and without prejudice to the generality of the foregoing, shall include :
 - (a) All assets (Movable or immovable) as listed in Annexure 'B' hereto;
 - (b) All liabilities, debts or obligations as listed in Annexure 'C' hereto;
 - (c) All permanent employees of J. K. Chemicals Ltd. engaged in or in relation to the Condom Division at their factory at Plot No. 35 and 36 MIDC Waluj Aurangabad,

Maharashtra or their offices at Mumbai, Delhi, Chennai and Calcutta as listed in Annexure 'D' hereto;



(d) All import licences and entitlements of J. K. Chemicals Limited as listed in Annexure 'E' hereto; and

(e) All leasehold rights, tenancy rights, permits, quota rights, industrial and other licences, trade marks, all the privileges and benefits of all contracts, agreements and all other rights, licences, powers and facilities of every kind, nature and description whatsoever appertaining to the Condom Division.

(iv) "Effective Date" means the last of the dates on which the sanctions, approvals or orders specified in this Scheme are obtained.

(v) "The Transferee Company" means J.K. CONDOMS PRIVATE Limited, a company incorporated under the Companies Act, 1956 and having its registered office at Plot No. G 35 and 36, MIDC, Waluj, Aurangabad, Maharashtra 431136.

(vi) "The Transferor Company" means J. K. Chemicals Limited a company incorporated under the Companies Act, 1956 having its registered office at New Hind House, N. Morarjee Marg, Ballard Estate, Mumbai - 400 001.

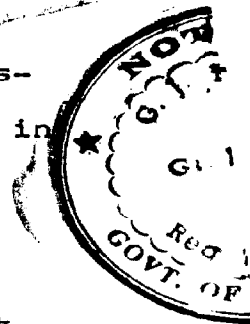

3. The CD of the Transferor Company shall be transferred to and vested in the Transferee Company in the following manner:

(a) With effect from the Appointed Day, the entire CD of the Transferor Company except for the portions specified in sub-clauses (b) and (c) hereof, of whatsoever nature and wheresoever situated and owned by the Transferor Company as on the Appointed Day and incapable of passing by manual delivery, shall under the provisions of Section 391 and 394 of the Act without any further act, deed, matter or thing but subject to the charges affecting the same as on the Effective Date be transferred to and vested in or be deemed to be transferred to and vested in the Transferee Company.

(b) All the movable assets of the Transferor Company including cash on hand but pertaining only to the CD of the Transferor Company shall be physically handed over by manual delivery to the Transferee Company to the end and intent that the property therein passes to the Transferee Company. The amounts lying with the Banks to the credit of the Transferor Company but pertaining only to the CD of the Transferor Company shall be transferred to the Transferee Company. Such delivery and transfer shall be made

--



on a date to be mutually agreed upon between the respective Board of Directors of the Transferor Company and the Transferee Company within thirty days from the date of the order of the Bombay High Court sanctioning this Scheme.

(c) In respect of movables other than those specified in sub-clause (b) above, including sundry debtors outstanding loans, and advances recoverable in cash or in kind or for value to be received and deposits with Government, Semi Government, Local and other authorities and bodies and customers etc. pertaining only to the CD of the Transferor Company, the following modus operandi shall be followed:

(1) the Transferee Company shall give notice in such form as it may deem fit and proper, to each party, debtor or depositor as the case may be, that pursuant to the Bombay High Court having sanctioned the arrangement between the Transferor Company, the Transferee Company and their members under Section 391 and 394 of the Act, the said debt, loan, advance, etc. be paid or made good or held on account of the Transferee Company as the person entitled thereto to the end and intent that the right of the Transferor Company to recover or realise the same stands extinguished and that appropriate entry should be passed in their respective books to record

-



the aforesaid changes.

- (ii) the Transferor Company shall also give notice in such form as it may deem fit and proper to each person, debtor or depositor that pursuant to the Bombay High Court having sanctioned the Arrangement between the Transferor Company, the Transferee Company and their members under sections 391 and 394 of the Act, the said person, debtor or depositor should pay the debt, loan or advance or make good the same or hold the same on account of the Transferee Company and that the right of the Transferor Company to recover or realise the same stands extinguished.

- (d) It is clarified that for this purpose, the value of the assets being so transferred shall be the value as appearing in the books of account of the Transferor Company as on the close of business on 30th day of June, 1996.

- (e) With effect from the Appointed Day, a sum of Rs. 30 lacs forming part of the Capital Reserve of the Transferor Company as on June 30, 1996 shall stand transferred to and form part of the Capital Reserve of the Transferee Company.

- (f) It is hereby clarified that the rest of the

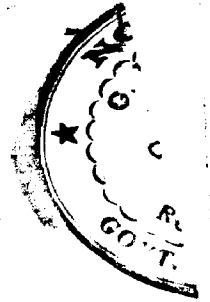

business and assets of the Transferor Company other than those specified in para 3 (a), 3(b), 3 (c) and (e) hereto shall continue to be vested in the Transferor Company.

4. It is further clarified that only the debts, liabilities, duties and obligations of the Transferor Company relating to the said CD as on the close of business on 30th day of June, 1996 and as identified in Annexure 'C' shall be the debts, liabilities, duties and obligations of the Transferee Company.
5. All legal or other proceedings by or against the Transferor Company pending on the Effective Date and relating to the CD (including property rights, powers, liabilities, obligations and duties of the Transferor Company) shall be continued and enforced by or against the Transferee Company.
6. With effect from the Appointed Day and upto and including the Effective Date, the Transferor Company:
 - (a) shall be deemed to have carried on and to be carrying on all business and activities relating to the CD of the Transferor Company and stand possessed of the properties so to be transferred, for and on account of and in trust for the Transferee Company;
 - (b) all profits accruing to the Transferor Company or losses arising or incurred by it relating

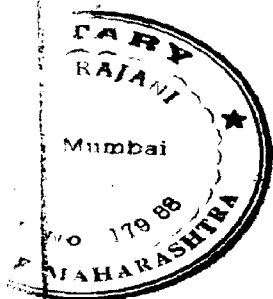

to the said CD shall, for all purposes, be treated as the profits or losses as the case may be of the Transferee Company.



7. The Transferor Company hereby undertakes from the Appointed Day upto and including the Effective Date:
 - (a) to carry on its business with proper prudence and not (without the prior written consent of the Transferee Company) to alienate, charge or otherwise deal with or dispose off the CD or any part thereof (except in the ordinary course of business) nor to undertake any new business or a substantial expansion of its existing business relating to CD;
 - (b) not to utilise the profits, if any, relating to the CD for the purposes of declaring or paying any dividend in respect of the period falling on and after the Appointed Day.

8. (a) The Transferee Company undertakes to engage, on and from the Effective Date, all permanent employees of the Transferor Company engaged in the CD of the Transferor Company at their factory at, Plot No. 35 and 36 MIDC Waluj Aurangabad, Maharashtra; and also at their offices at Aurangabad, Mumbai, Calcutta, Delhi and Chennai and who are in the employment of the Transferor Company, on the same terms



and conditions on which they are engaged as on the Effective Date by the Transferor Company without any interruption of services as a result of the transfer. The Transferee Company agrees that the services of all such employees with the Transferor Company upto the Effective Date shall be taken into account for purposes of all retirement benefits to which they may be eligible in the Transferor Company on the Effective Date. The Transferee Company further agrees that for the purpose of payment of any retrenchment compensation, such past services with the Transferor Company shall also be taken into account)

- (b) The accounts of the employees, who are employed by the Transferor Company under sub-clause (a) above, in the Transferor Company relating to Superannuation, Provident and Gratuity Fund shall be identified and determined and transferred to the Trustees of the respective funds of the Transferee Company.

- 9. Subject to other provisions of this Scheme all contracts, deeds, bonds, agreements, insurance policies and other instruments of whatsoever nature relating to the CD of the Transferor Company to which the Transferor Company is a party subsisting or having effect on or before the Effective Date shall be in full force and effect against or in favour of the

Transferee Company, and may be enforced as fully and effectually as if, instead of the Transferor Company, the Transferee Company, had, at all material times, been a party thereto.



10. In consideration of the transfer of CD to the Transferee Company, the Transferor Company shall be entitled to be allotted 9,99,990 equity shares in the Transferee Company of Rs. 10/- (Rupees Ten) each credited as fully paid up as also the Transferor Company shall be paid by the Transferee Company a sum of Rs. 4,51,42,161/-.

11. The new equity shares of the Transferee company to be issued and allotted in accordance with clause 10 hereof, shall rank for dividend, voting rights and in all other respects paripassu with the existing equity shares of the Transferee Company.

P A R T - C

12. On the Scheme being agreed to by the requisite majorities of the members of the Transferor Company and by the members of the Transferee Company each of them, the Transferor Company and the Transferee Company, shall with reasonable despatch, apply to the High Court of Judicature at Bombay for sanctioning this Scheme of Arrangement under Section 391 of the Act and for an

--

order or orders under Section 394 of the Act for carrying this Scheme into effect.

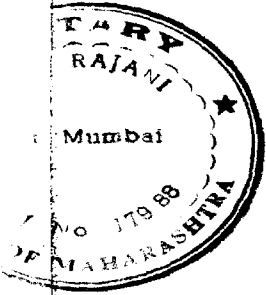
13. The Transferor Company (by its Directors), and the Transferee Company (by its Directors) may, in their full and absolute discretion, jointly assent to any alteration or modification of this Scheme which the Court and/or any other Competent Authority may deem fit to approve or impose and may give such directions as they may consider necessary to settle any questions or difficulty arising under the Scheme or in regard to its implementation or in any matter connected therewith; (including any question or difficulty arising in connection with any deceased or insolvent shareholder of the respective Companies). In the event that any conditions are imposed by any Competent Authority which the Transferor Company and the Transferee Company finds unacceptable for any reason whatsoever then the Transferor Company and the Transferee Company shall be entitled to withdraw from the Scheme.

14. The Scheme is conditional upon and subject to:
- (a) The scheme being agreed to by the respective requisite majorities as are referred to in Clause 12 hereof (on behalf of the Transferor Company and the Transferee Company) and the requisite Order or Orders referred to in Clause 12 being obtained;



(b) Such other sanctions and approvals as may be required by law in respect of the Scheme being obtained.

15. Unless otherwise agreed to by the respective Boards of the Transferor Company and the Transferee Company within 60 days from the Effective Date, the Transferee Company shall issue and allot 9,99,990 Equity Shares of Rs. 10 each to the Transferor Company credited as fully paid-up and shall also pay the Transferor Company the said sum of Rs. 4,51,42,161/- in accordance with clause 10 of the Scheme.
16. All costs, charges and expenses including stamp duty and registration fee of any deed, document, instrument or court's order of the Transferor Company and the Transferee Company respectively in relation to or in connection with negotiations leading upto the Scheme and of carrying out and implementing the terms and provisions of this Scheme and incidental to the completion of arrangement of transfer of the said CD of the Transferor Company in pursuance of this Scheme shall be borne and paid entirely by the Transferee Company.
17. In the event of this Scheme failing to take effect finally before the 30th day of November,



1997 or within such further period or periods as may be agreed upon between the Transferor Company (by its Directors) and the Transferee Company, this Scheme shall become null and void and in that event no rights and liabilities whatsoever shall accrue to or be incurred inter se to or by the parties or any of them.

Description of the Condom Business of J.K.Chemicals Limited (JKCL)

JKCL's Condoms manufacturing plant, with an estimated annual capacity of 250 million pieces, is located at Plot G-35 and 36 MIDC Waluj, District Aurangabad. The total land area is 35,520 sq mts and the total built up area of the plant is 5,520.712 sq mts.

The plant was set up in 1991 under technical collaboration with a South Korean company, with an initial investment of about Rs 157 million. Commercial production commenced in January 1992.

The Condoms division manufactures and sells various brands of condoms viz, Kama-Sutra, Midnight Cowboy, Safari, etc, in domestic and export markets and Nirodh to the Government of India's Family Welfare Programme. In addition, condoms are also sold in Bulk - naked and tested and Foil sealed condition.

The Condoms division has received accreditation from the South African Bureau of Standards for Kama-Sutra, Midnight Cowboy and Safari condoms. In addition, the 510(k) approval has also been received from the US FDA.

JKCL's Condom division also sells Nirvana, an ayurvedic vitaliser capsule, which is manufactured by a third party, as per the specifications given by JKCL.

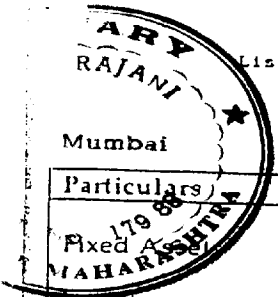
JKCL's Condom division also undertakes distribution activities of various consumer products in the domestic market.

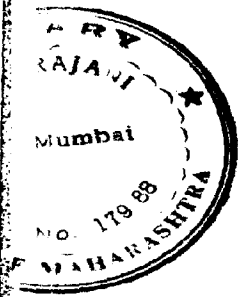

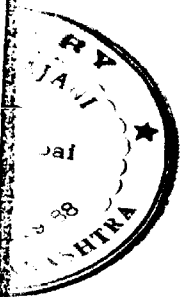

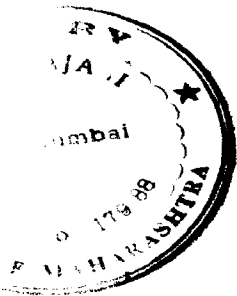
