TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT is entered into this 22nd day of January, 1997, by and between MOUNTAINSMITH, INC., a Colorado corporation with its principal place of business located at 18301 West Colfax Avenue, Golden, Colorado 80401, and White River Outfitters, Inc., an Arkansas corporation with its principal place of business located at 2nd and Dalton, Cotter, Arkansas 72626 (collectively, "Assignors"), and Mountainsmith LLC, a Delaware limited liability company with its principal place of business located at 18301 West Colfax Avenue, Golden, Colorado 80401 ("Assignee").

WHEREAS, Assignors and Kohn Acquisition Corporation, a Colorado corporation ("Kohn Acquisition"), have previously entered into that certain Asset Purchase Agreement dated as of November 5, 1996, as amended (the "Asset Purchase Agreement");

WHEREAS, one or both of the Assignors are the owners of certain trademarks, servicemarks, trade name and trade dress (the "Marks") used in connection with the designing, manufacturing, advertising and selling of backpacking, mountaineering and other recreational equipment (the "Business");

WHEREAS, pursuant to the Asset Purchase Agreement Assignors have agreed to transfer entire ownership of all Marks and associated goodwill related to the Business to Kohn Acquisition;

WHEREAS, Kohn Acquisition and Assignee have entered into the Assignment and Assumption Agreement, dated January 22, 1997, providing for, among other things, the assignment by Kohn Acquisition, and the assumption by Assignee, of all of Kohn Acquisition's rights and obligations under the Asset Purchase Agreement, including the right to assignment of the Marks;

NOW, THEREFORE, in consideration of the foregoing premises and of the mutual covenants and obligations contained herein and in the Asset Purchase Agreement, the parties hereto agree as follows:

Assignors hereby grant, transfer, assign and convey to Assignee, its successors and assigns, the entire title, interest, ownership, and rights, whether statutory or at common law, in and to the Marks, including without limitation those described in Exhibit A attached hereto and incorporated herein by reference, and all goodwill associated therewith, and all registrations and pending applications therefor, in the United States of America, in any of the states, and in any foreign country, together with all causes of action for any and all previously occurring infringements of the rights assigned hereunder and the right to receive and retain the proceeds relating to those infringements. Whether the rights shall be enforced, exploited, preserved, registered or maintained is at the sole discretion of the Assignee.

The parties hereto agree to execute and deliver, or cause to be executed and delivered, such documents and instruments and shall take, or cause to be taken, such further or other actions as may be reasonably necessary to effectuate the transactions contemplated hereby.
