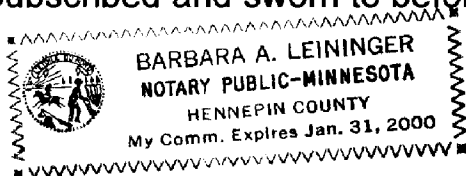

POTTER PRODUCTION CORPORATION


