

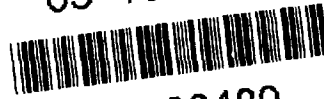

## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made as of the 26<sup>th</sup> day of April 1999, by and between KAREN S. FRANK, an individual, with a business address of Legal Strategies Group, 5905 Christie Avenue, Emeryville, CA 94608 ("Assignor") and LEVI STRAUSS & CO., a Delaware corporation with an address of 1155 Battery Street, San Francisco, CA 94111 ("Assignee").

WHEREAS, by virtue of that certain Trademark Assignment dated as of the 26th day of April, 1999, Assignor is the owner of all worldwide right, title and interest in and to the trademark XACTLY for wearing apparel (the "Mark"), along with the goodwill of the business symbolized thereby (the "Goodwill"), and of United States Trademark Registration No. 1,836,235 for the Mark (the "Registration"), all as previously owned by Tony Marterie & Associates, D/B/A North Coast Industries, Inc. ("North Coast"); and

WHEREAS, in the course of assigning the Mark, the Goodwill and the Registration to Assignor, North Coast represented and warranted to Assignor that it was holder of all right, title and interest in and to the Mark and the Registration; that the Mark was free and clear from all encumbrances, including any licenses; that North Coast had not, to its knowledge, been charged with trademark or service mark infringement or unfair competition by any third party by reason of the use of the Mark by it or by any licensee of it; and that North Coast was not aware of any claims, objections or protests to the use of the Mark and any other trademark, service mark, trade name or other indicia of origin of any third party (the "Warranties"); and

WHEREAS in the course of assigning the Mark, the Goodwill and the Registration to Assignor, North Coast agreed to indemnify Assignor and Assignor's subsequent Assignee from any and all claims and liabilities, including reasonable attorney's fees, arising from North Coast's use of the Mark (the "Indemnification"); and

WHEREAS Assignor obtained all of North Coast's rights in the Mark, the Goodwill and the Registration, and obtained the Warranties and Indemnification, for the purpose of reassigning the same to Assignee; and

WHEREAS Assignee wishes to obtain all of the rights Assignor obtained from North Coast in the Mark, the Goodwill and the Registration, along with the Warranties and Indemnification:

N O W T H E R E F O R E, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

Assignor hereby assigns unto Assignee all of the right, title and interest Assignor obtained from North Coast in and to the Mark, along with the goodwill of the business symbolized thereby, and the Registration, along with the Warranties and Indemnification.
