

Assignor agrees to execute and deliver at the request of Assignee, all paper, instruments, assignments, artwork or design work associated with the mark and to perform any other reasonable acts the Assignee may require in order to vest all Assignor's rights, title and interest in and to the mark in the Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by the Assignee, to the extent such evidence is in the possession or control of Assignor.

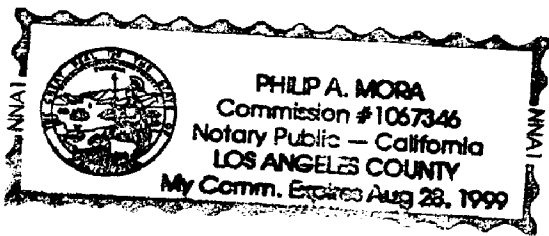
