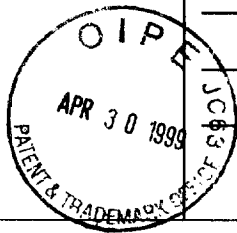



**TRADEMARK ASSIGNMENT**

This Trademark Assignment is made this 27 day of April, 1999, between A2S2 Digital Projects, Inc., a Delaware corporation, having a principal business address at 875 North Michigan Avenue, Suite 3370, Chicago, Illinois 60611 ("Assignor"), in favor of ESB.COM, LLC, a Delaware limited liability company, having a principal business address at 875 North Michigan Avenue, Suite 3370, Chicago, Illinois 60611 ("Assignee").

WHEREAS, Assignor owned all right, title and interest in and to the trademarks and service marks on the attached Schedule A (hereinafter, the "Marks");

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are acknowledged, Assignor hereby sells, assigns, transfers and sets over to Assignee, the entire right, title, and interest in and to the Marks and the pending applications for federal registration and federal registrations of the Marks, including the right to sue for past and future infringement, together with the goodwill of the business symbolized by the Marks, and the portion of Assignor's business to which the Marks pertain, the same to be held and enjoyed by Assignee, its successors, assigns and other legal representatives.
