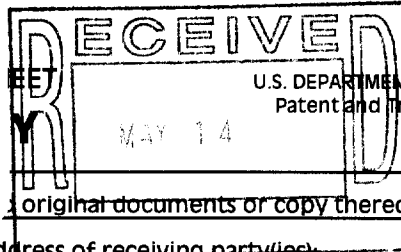

ARTICLES OF AMENDMENT TO THE CHARTER
