I, Phyllis Ann Roof, a resident of and domiciled in Lexington County, South Carolina, being of sound mind and memory, do hereby make, publish and declare this to be my Last Will and Testament, hereby revoking all Wills and Codicils at any time heretofore made by me.

ARTICLE I:        I Direct that all my just debts and the expenses of the administration of my estate be paid as soon after my death as practicable.

*OAK*  
 ARTICLE II:       I give, devise and bequeath unto my husband, James Larry Roof, absolutely and in fee simple all of the rest of my property, real and personal, of every kind and description (including lapsed legacies and devises) wherever situate and whether acquired before or after the execution of this Will which I may own or have the right to dispose of at the time of my death.

ARTICLE III:     In the event that my husband, James Larry Roof, shall predecease me or he and I should die as a result of a common disaster or accident, I give, devise, and bequeath all of my property, real and personal, of every kind and description (including lapsed legacies and devises) wherever situate and whether acquired before or after the execution of this Will in the following shares to James Shawn Roof, thirty (30%) percent; to James Shannon Roof, thirty (30%) percent; to Dee Ann Roof, thirty five (35%) percent; and to Janette Arlene

Randall, five (5%) percent.

ARTICLE IV: If James Larry Roof shall predecease me, or if he dies after my death without having appointed a Testamentary Guardian for our children, James Shawn Roof and James Shannon Roof, then I hereby nominate, constitute and appoint Dee Ann Roof and Janette Arlene Randall as Testamentary Guardians of the person and the property of such children and to the extent allowed by law direct that such Guardians shall serve without bond.

ARTICLE V: I hereby nominate, constitute, and appoint as Trustees of this my Last Will and Testament, Dee Ann Roof, and Janette Arlene Randall, and direct that they shall serve without bond.

ARTICLE VI: In the event that James Shawn Roof and James Shannon Roof have not attained the age of sixty-five (65) years at the time of my death, then I direct my executor herein to transfer, convey and assign all of the property conveyed or distributable to my said beneficiary(s) in this Will to Dee Ann Roof and Janette Arlene Roof as Trustees and to hold the property of my said beneficiary(s) taking into consideration to the extent my Trustees deem advisable any other income or resources of my said beneficiary(s) or of the beneficiary(s) guardian known to my Trustees. My beneficiary(s) property shall be paid over and distributed upon the beneficiary(s) attaining the age of sixty-five (65) years, or if the beneficiary shall sooner die, to the estate of the beneficiary. Whenever my Trustees determine it appropriate to pay any money for the benefit of my said

beneficiary(s) for whom a trust is created hereunder, then such amount shall be paid out by my Trustees in such of the following ways as my Trustees deem best:

1. Directly to my said beneficiary;
2. To the legally appointed guardian of my said beneficiary;
3. To some relative or friend for the support, medical care and education of my said beneficiary;
4. By my Trustees using such amounts directly for my said beneficiary(s) support, medical care, and education. In holding any property for my beneficiary(s) under the provisions of this item, my Trustees shall have all the powers and discretions hereinbefore conferred upon it as Trustee and they are specifically directed to prudently invest my said beneficiary(s) property under the Trust created hereunder.

ARTICLE VII: If any beneficiary and I should die as the result of a common accident or calamity or otherwise under such circumstances as would render it doubtful whether the beneficiary or I died first, then it shall be conclusively presumed for the purposes of this Will that the said beneficiary predeceased me.

ARTICLE IX: By way of illustration and not of limitation, and in addition to any inherent, implied or statutory powers granted to Trustees generally, my Trustees are specifically authorized and empowered: to allot, assign, buy, care for, collect, contract with respect to, continue any business of mine, convey, convert, deal with, dispose of, enter into, exchange, hold, improve, incorporate any business of mine, invest, lease, manage, mortgage, grant and exercise options with respect to, take possession of, pledge, receive, release, repair, sell, sue for and in general, to exercise all the powers in the management of my estate which any individual could exercise in the management of similar property owned in his own right, upon such terms and conditions as my Trustee may deem best, and to execute and deliver any and all instruments and to do all acts which my Trustee may deem proper or necessary to carry out the purposes of this Will without being limited in any way by the specific grants of power made and without the necessity of a court order.

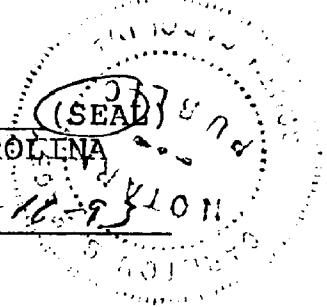

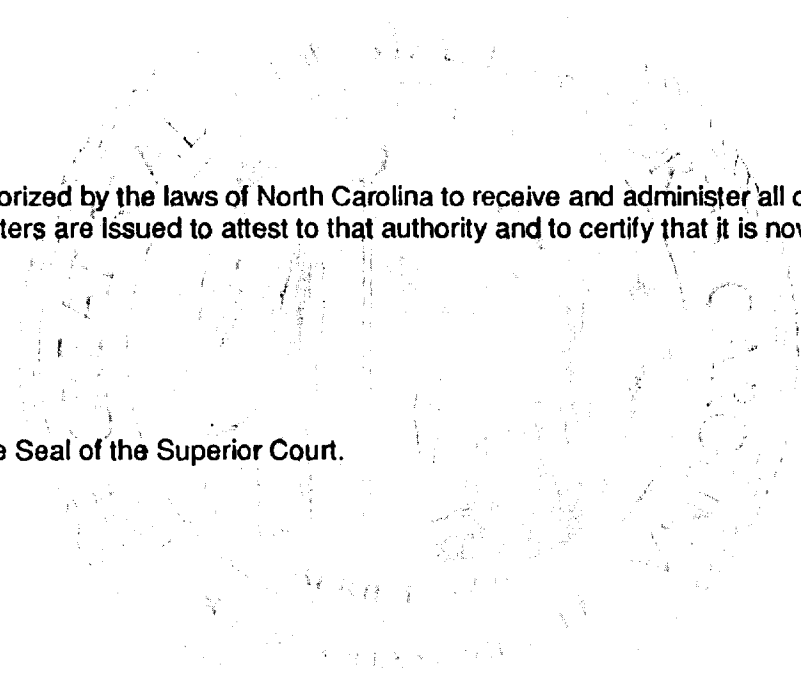
