REASSIGNMENT OF TRADEMARKS AND SERVICE MARKS

BayBank, a Massachusetts trust company, having its principal place of business at 7 New England Executive Park, Burlington, Massachusetts 01803 (hereinafter the "**Bank**"), assignee pursuant to an Assignment of Trademarks and Service Marks as Collateral given by The Shelburne Corporation, a Vermont corporation, having its principal place of business at Route 7, P.O. Box 158, Shelburne, Vermont 05482 (hereinafter the "**Borrower**") dated as of July 16, 1993 and recorded with the United States Patent and Trademark Office on Reel 1002, Frame 249, et seq.
