RELEASE OF SECURITY INTEREST IN TRADEMARKS

Release made as of March 5th, 1999, by Norwest Business Credit, Inc., a Minnesota corporation, (the "Secured Party") of Seyfert Foods, Inc., a Delaware corporation (the "Debtor").

WHEREAS, certain trademarks of the Debtor (the "Trademarks") have been granted federal and/or state trademark registrations (the "Registrations"), with the federal trademark Registrations being listed in Exhibit A attached hereto, and the state trademark Registrations being listed in Exhibit B attached hereto;

WHEREAS, on May 22, 1997, the Secured Party obtained a security interest in the Trademarks, and the Secured Party recorded such security interest with the United States Patent and Trademark Office on September 23, 1997;

WHEREAS, the Debtor has satisfied its debt owed to the Secured Party; and

WHEREAS, the Debtor desires such security interest to be released, and the Secured Party is willing to make such release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is acknowledged, the Secured Party hereby releases its entire security interest in the Trademarks together with the goodwill of the business symbolized by the Trademarks; all right, title and interest in and to the Trademarks; any licenses thereunder; all rights in the Registrations; all rights to seek other registrations of the Trademarks in the United States Patent and Trademark Office or elsewhere; and all causes of action, past and future, for infringement of the Trademarks or other violations of the rights in the Trademarks.
