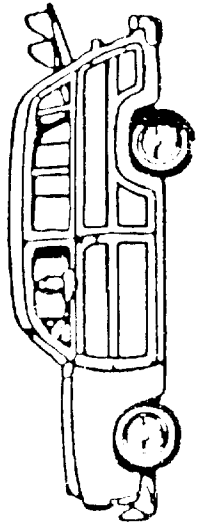
WHEREAS, Assignor has adopted and is the owner of the marks identified on Exhibit "A" attached hereto (the "Marks"); and
