U.S. TRADEMARK ASSIGNMENT

THIS ASSIGNMENT is effective this 30th day of April, 1999 ("Effective Date"), from **MILLER BREWING COMPANY**, a Wisconsin corporation located at 3939 West Highland Boulevard, Milwaukee, WI 53208 ("Assignor"), to **PABST BREWING COMPANY**, a Delaware corporation located at 100 Shoreline Highway, Mill Valley, CA 94941 ("Assignee").

WHEREAS, Assignor is the owner of all right, title and interest in and to certain intellectual property relating to the Colt 45 Rights (as defined in the Exchange Agreement dated as of February 8, 1999, to which Assignor and Assignee are both parties and pursuant to which this Assignment is made and which is further defined in the Purchase and Sale Agreement dated as of February 8, 1999, between Assignor and The Stroh Brewery Company) including, but not limited to, all rights, priorities and privileges relating to said intellectual property of Assignor, and all rights to sue at law or in equity for any infringement or other impairment thereof, including the right to receive all proceeds and damages therefrom and the registrations, applications, and related licenses listed on Schedule A (hereinafter, the "U.S. Colt Marks"); and

WHEREAS Assignee wishes to acquire from Assignor the U.S. Colt Marks and the goodwill associated therewith.

NOW, THEREFORE, for good and valuable consideration (including that recited in the Exchange Agreement dated as of February 8, 1999), the receipt and adequacy of which is hereby acknowledged, Assignor hereby sells, assigns, transfers and conveys to Assignee, its successors and assigns forever, free and clear of all liens and encumbrances, Assignor's entire right, title and interest in the U.S. Colt Marks, together with the goodwill of Assignor's business appertaining thereto, all income, royalties, damages and payments now or hereafter due or payable in respect to the U.S. Colt Marks and all causes of action (either in law or in equity) and the right to sue, counterclaim and recover for past, present and future infringement and/or dilution of the U.S. Colt Marks and the rights thereto.

Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any other official whose duty it is to issue trademarks, to issue the same to the said Assignee, its successors and assigns, in accordance with the terms of this assignment.

Assignee, its successors and assigns, shall hold the rights to the foregoing for and during the existence of such U.S. Colt Marks, as fully and as entirely as the same would have been held and enjoyed by Assignor had this assignment not been made.

Assignor also shall, without further considerations, comply with all reasonable requests by Assignee, at no expense, to execute promptly any additional documents and to take promptly any further action necessary to vest good, valid and marketable title to the U.S. Colt Marks in the Assignee.


