RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, General Brewing Company ("General"), having its chief executive office and mailing address at 100 Shoreline, Suite 315, Mill Valley, California 94941, did execute and deliver to American National Can Company ("ANC"), with its mailing address at 8770 West Bryn Mahr Ave Chicago, Illinois 60631, a certain Security Agreement ("Security Agreement") and a certain Notice and Grant of Security Interest in Trademarks (the "Trademark Security Agreement"), each dated as of March 10, 1997; and

WHEREAS, the Trademark Security Agreement was originally recorded in the United States Patent and Trademark Office at Reel 1567, Frame 0675 on March 17, 1997; and


WHEREAS, the Security Agreement and/or the Trademark Security Agreement granted, assigned and conveyed to ANC a security interest in certain property, (such property to be referred to herein as the "Secured Property") including but not limited to General's right, title, and interest in and to certain trademarks, trademark registrations, trade names, and trademark applications, appearing on Schedule A attached hereto, and as described in the Security Agreement and/or the Trademark Security Agreement (the "Trademarks"); and

WHEREAS, ANC represents and warrants to General that it has not sold, assigned, pledged or otherwise transferred or encumbered all or any part of its interest in the Secured Property, including but not limited to the Trademarks, and that it has the full power and authority to make this Release and Termination;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ANC does hereby cancel and terminate the Security Agreement and the Trademark Security Agreement, declare the same null and void, of no further force and effect, and further releases, cancels and terminates its entire interest in all of the Secured Property, including but not limited to the Trademarks described in the Security Agreement and/or the Trademark Security Agreement.
