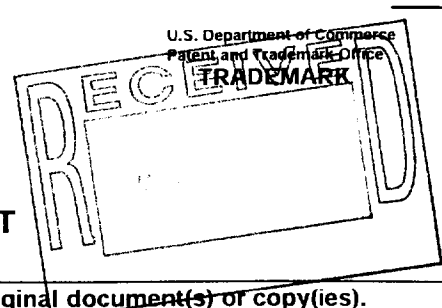

TRADEMARK ASSIGNMENT

ASSIGNMENT made on March 30, 1999 by Fletcher Granite Company, Inc., a Massachusetts corporation ("Fletcher"), and New England Stone Industries, Inc., a Rhode Island corporation ("Stone") (each an "Assignor," and collectively the "Assignors"), to FG Acquisition, LLC, a Massachusetts limited liability company ("FG"), and Stone (collectively the "Assignees").

RECITALS:

WHEREAS, the Assignors are the joint owners of the trademark "DEER ISLE" issued to Fletcher and Stone, and listed on the Principal Register of the U.S. Patent and Trademark Office as Registration No. 2,009,241, registered on October 22, 1996 (the "Mark"), which Mark is now in full force and has not expired, been canceled or abandoned;

WHEREAS, FG has acquired substantially all of the assets of Fletcher pursuant to an Asset Purchase Agreement executed contemporaneously herewith, including the Mark and the good will associated with Fletcher's Business, as defined in the Asset Purchase Agreement; and

WHEREAS, the Assignors wish to jointly assign and the Assignees wish to acquire all of Assignors' right, title and interest in and to the Mark, such that FG shall accede to Fletcher's entire right, title and interest in and to the Mark, and that after such assignment, FG and Stone shall be joint owners of the Mark.

NOW, THEREFORE, the Assignors, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, do hereby sell, assign and transfer unto the Assignees, their successors and assigns, each of Assignors' entire right, title and interest in and to said Mark together with the goodwill thereto and all claims for damages and profits by reason of any past infringement or injury to said goodwill and the right to sue therefor, such interest to be held to the full end of the term for which such Mark or any renewals or extensions thereof are or may be granted, the same to be held and enjoyed by Assignees for their own use, as joint owners thereof, and for their successors and assigns, as fully and entirely as the same would have been held by Assignors had this Assignment not been made.
