Dallas Corporation (the "Corporation"), existing pursuant to the Indiana Business Corporation Law and desiring to give notice of corporate action effectuating an amendment of its Articles of Incorporation, sets forth the following facts:

Article I

Section 1. The date of incorporation of the Corporation is June 15, 1923.

Section 2. The name of the Corporation prior to effectiveness of this amendment is Dallas Corporation, and by means of this amendment the name of the Corporation is being changed to Overhead Door Corporation.

Section 3. Upon effectiveness of these Articles of Amendment, Article I of the Corporation's Articles of Incorporation shall be amended to read in its entirety as follows:

Name

The name of the Corporation is Overhead Door Corporation.

Section 4. The foregoing amendment was duly approved and adopted by the Corporation's sole shareholder

on March 15, 1990. The effective date of such amendment shall be the date of filing of these Articles of Amendment with the Office of the Secretary of State of the State of Indiana.

### Manner of Adoption and Vote

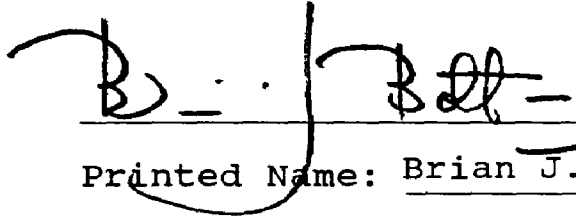
