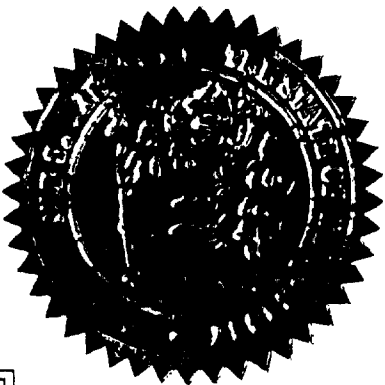

The name of the Corporation is PCI Global Inc.






