

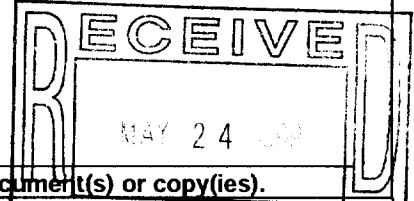

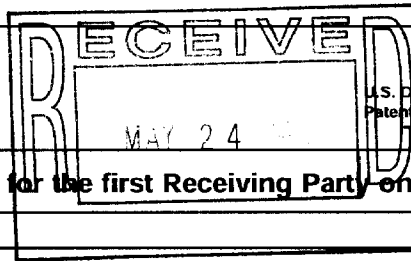

TRADEMARK ASSIGNMENT

ASSIGNMENT made on March 26th, 1999 by Fletcher Granite Company, Inc., a Massachusetts corporation ("Assignor") to FG Acquisition, LLC, a Massachusetts limited liability company ("Assignee").

RECITALS:


