

4. Any and all other rights and privileges provided under the copyright, trademark, unfair competition and other laws of the United States, the individual states thereof and jurisdictions foreign thereto with respect to the foregoing; any and all rights to and under any and all licenses and other agreements and documents relating to any of the foregoing; and any and all rights of publicity and waivers of privacy rights of any and all persons whose names, images, likenesses and other identifying indicia are included in the subject matter to which the foregoing relates.

This Assignment is made in accordance with and subject to the representations, warranties, covenants, indemnities and other provisions contained in the Asset Purchase Agreement dated as of February 1, 1999 by and between the Assignor and the Assignee.


