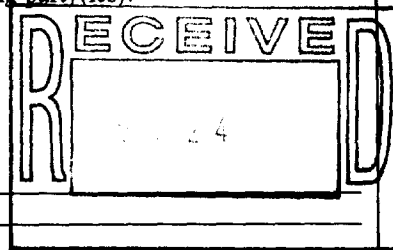

Assignor further agrees to execute any and all documents and do any such further acts that shall be required in order for Assignee to secure such rights, all without further compensation to Assignor.

Assignor hereby covenants that it has full right to convey the entire interest herein assigned.


