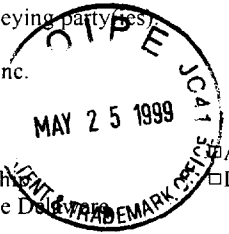

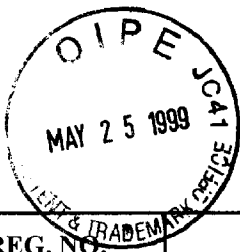

## ASSIGNMENT

Assignor agrees to execute all such other documents as may be reasonably needed to establish Assignee as the record owner of the Mass-Market Trademarks.
