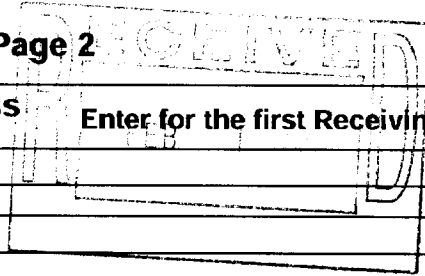

TRADEMARK ASSIGNMENT

This Assignment of all rights ("Assignment") is entered into as of December 17, 1997, by and between Dr. Alvin Meyer ("Assignor") and Darway, Inc. ("Assignee").

Assignor invented a dental contact retaining ring and has been using the mark BITINE in connection with this dental contact retaining ring since at least as early as 1965. Assignor has also been using the mark PALODENT in connection with a dental matrix system since at least as early as 1965.

Assignor obtained a federal registration for the mark BITINE in 1997. The federal trademark registration number is 2121758 (attached hereto as Exhibit A). Assignor also obtained a federal registration for the mark PALODENT in 1997. The federal trademark registration number is 2116300 (attached hereto as Exhibit B). The marks BITINE and PALODENT are collectively referred to herein as the Marks.

Assignee is a corporation which was formed in 1994. Assignee manufactures, distributes and sells dental related goods, including contact containing rings and matrix systems. In 1994, Assignor granted Assignee a license to use the Marks. Since 1994, Assignee has continued to produce high quality contact retaining rings and matrix systems.

Assignor now wishes to assign all of his goodwill, rights, title and interest (including, but not limited to, all federal, state, and common law rights) in and to the use of the Marks to Assignee.

For valuable consideration, receipt of which is hereby acknowledged, the parties acknowledge the above recitals and agree as follows:

1. Assignor hereby assigns, sells, conveys and transfers to Assignee all rights, title and interest in the Marks. This assignment includes, without limitation, all goodwill developed in the marks, all rights to use of the marks, and all choses in action for infringement of the marks.
2. Assignee hereby accepts the Assignment and assumes all rights and obligations arising out of this Assignment.
3. Assignee agrees to pay Assignor \$1,000.00; receipt of which is hereby acknowledged.

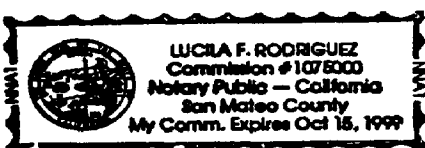

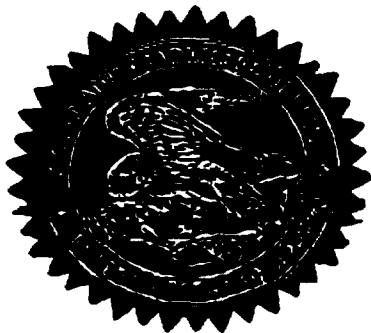
