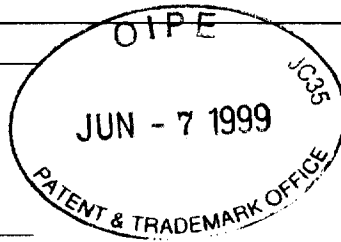

THIS RELEASE AND REASSIGNMENT dated as of May 25, 1999, by Firststar Financial Services, a division of Firststar Bank Milwaukee, N.A. ("Bank").


WHEREAS, Borrower has repaid its obligations to Bank and has requested that Bank release its security interest in the Collateral and reassign the same to Borrower.
